## **South Carolina Sea Grant Funding Opportunities**



Sea Grant is seeking proposals for its National Sea Grant College program, which seeks to support two projects as part of the Sea Grant Federal Partnership Liaison program and will have approximately \$200,000 per year for four years. The National Federal Partnership Liaisons will work with the Sea Grant Network and federal partners to identify needs and products on key national Sea Grant topics (e.g. hurricanes, flooding, and coastal storms, marine, aquatic and coastal hazards, fishing communities). The Department of Education's Institute of Education Sciences (IES) grants program supports research in expanding knowledge and understanding of (1) developmental and school readiness outcomes for infants and toddlers with a disability, (2) education outcomes for all leaners from early childhood education through postsecondary and adult education, and (3) employment and wage outcomes when relevant. This program is designed to provide the public with reliable and valid information about education practices that support learning and improve academic achievement for all learners.
