

NASA SC Space Grant Consortium Funding Opportunities: REAP & Palmetto Academy Programs



The NASA SC Space Grant Consortium's (SCSGC) Research and Education Awards Program (REAP) provides support for faculty members and/or students for the development of contacts and collaborations that will bring SC faculty into the mainstream of research activity, thereby increasing their chances for successfully competing in the research and education marketplace. The overall goal of REAP is to effectively utilize the SCSGC resources to: 1) develop new research projects or directions, 2) obtain unique training and exposure, and 3) foster collaborations among the campuses, as well as with NASA and/or other federal agencies and the aerospace industry. Faculty members are eligible to apply to any of four subprograms: The Research Facilitation Award Subprogram, The Education Research Award, The Curriculum Development Award Subprogram, and The Travel Award Subprogram. The Palmetto Academy Faculty and Student Programs support faculty and student led research projects with relevance to the [NASA Strategic Plan 2018](#), the [NASA Mission Directorate](#) priorities, as well as [South Carolina's Science and Technology Vision 2025](#) in order to meet the growing need by NASA for skilled science and engineering workers in South Carolina. The faculty program funds principal investigators leading undergraduate/graduate research training projects. The student program funds undergraduate and graduate student led research projects. The LQAGP supports arts organizations and projects that reflect artistic excellence and events which are well-advertised and open to the public, and provides assistance for professional or career development for individual artists and staff of cultural organizations in Berkeley, Charleston and Dorchester Counties. The Public Humanities Projects program supports projects that helps humanities programs reach new audiences through public programming. This opportunity supports three types of projects: Exhibitions, Historic Places, and Humanities discussions. Proposed projects can apply for funding for either the planning or implementation side of these projects. Applications are due January 12, 2022. For more information please, [click here](#).

The Sustaining Cultural Heritage Collections program aims to help cultural institutions preserve large holdings of humanities materials through supporting sustainable conservation methods that both preserve the collections and increase the resilience of the institution. Projects can include reducing the use of fossil fuels, improving its financial health, preparing for natural emergencies or benefiting green initiatives. Applications are due January 13, 2022. The Digital Humanities Advancement Grant is available to innovative, challenging, or experimental digital projects that may enhance research, teaching, or public programming in the humanities. Research projects must respond to at least one of four priorities for the grant. These priorities include researching computationally challenging methods, enhancement and design of digital infrastructure, research that examines the history or ethics of digital culture, and evaluative studies that investigate the impact of digital scholarship on research. This grant supports projects that address urgent and emerging issues that threaten to damage the economic viability of estuarine areas.
