The Spencer Foundation – Funding Opportunities in Education Research



The Spencer Foundation invests in education research. The Foundation's Conference Grant Program provides support to scholars to organize small research conferences, focused symposia, or other forms of convening around important issues in education research. This program is intended to bring together researchers, community members, practitioners, policymakers, and other important collaborators whose expertise, substantive knowledge and practice, theoretical insight, or methodological expertise that can advance education research. Proposals should explore the understanding of research methods and how new innovative research methods can impact educational research that is grounded in advancing racial equity. Projects budgets must not exceed \$50,000. The application deadline is October 11, 2022. For more information please, [click here](#).

The Research-Practice Partnership (RPP) Grants Program is intended to support education research projects that engage in collaborative and participatory partnerships. The Spencer Foundation views partnerships as an important approach to knowledge generation and the improvement of education, broadly construed. Projects budgets may not exceed \$400,000 in total costs for project durations up to three years. Applications open September 14, 2022. The Simons Foundation – Grants in Mathematical and Physical Sciences



The Simons Foundation's mission is to advance research in mathematics and the basic sciences by supporting individual investigators and their research projects. The Simons Foundation's Mathematics and Physical Sciences (MPS) division invites applications for the Simons Collaborations in MPS program. The aim of the program is to stimulate progress on fundamental scientific questions of major importance in mathematics, theoretical physics and theoretical computer science. The proposed project should: (1) address a mathematical or theoretical topic of fundamental scientific importance, where a significant, new development creates a novel area for exploration or provides a new direction for progress in an established field; (2) have clearly defined initial activities and goals by which progress and success can be measured; and (3) involve outstanding researchers in a range of career stages. The National Endowment for the Humanities (NEH) – Collaborative Research Program



The NEH Collaborative Research program aims to advance humanistic knowledge by fostering rich scholarship and supporting sustained collaboration by teams of two or more scholars. Collaborators may have natural or social science backgrounds, come from one or more institutions, or may be international. Researchers may propose research in a single field of study or interdisciplinary work. Projects must address humanistic questions, employ humanistic methods, and aim to result in tangible or sustainable outcomes. Proposed projects are also encouraged to incorporate multiple points of view and pursue new avenues of inquiry in the humanities. The program includes four project categories: Planning International Collaboration, Convening, Manuscript Preparation, and Scholarly Digital Projects. The Application deadline is November 30, 2022.
