AHRQ Small Research Grant Program: Due 16 JUN 2024

[The AHRQ Small Research Grant Program](#) from the Department of Health and Human Services funds proposals that match AHRQ's research priorities; including improving healthcare quality, patient safety, and enhancing whole-person healthcare delivery. Research may also involve partners such as healthcare organizations, providers, local, state, or federal government, clinicians, non-clinical healthcare staff, and policymakers. **Grants can request up to \$100,000 in total costs. The full proposal is due June 16, 2024.**

South Carolina Urban, Community and Pollinator Garden Projects: Due 5 MAY 2024

[The South Carolina Urban, Community and Pollinator Garden Projects](#) from the Department of Agriculture funds proposals that create agricultural innovation, increase food security that is nutritious and affordable, can have positive impacts on rural and tribal communities, and promotes environmental justice in urban, rural, and tribal communities. Projects should develop new ways to address small scale garden space. Projects are encouraged to use native and specialty plants. **The grant be between \$25,000 and \$100,000 for one to three years. The full proposal is due May 5, 2024.**



National Fish Passage Program Bipartisan Infrastructure Law: Restoring River, Floodplain, and Coastal Connectivity and Resiliency: Due 31 DEC 2024

[The National Fish Passage Program](#) from the Department of the Interior's Fish and Wildlife Service supports projects that remove instream barriers, restore aquatic organism passage, and restore climate resilient aquatic connectivity in rivers, floodplains, and coastal habitats for the benefit of Federal trust resources. **The grant funding request should be between \$250,000 and \$1,000,000. Full proposals are due December 31, 2024, at 11:59 p.m.**

Health Sciences



Expanding the National Approach to Chronic Disease Education and Awareness: DUE 10 MAY 2024

[The Expanding the National Approach to Chronic Disease Education and Awareness](#) from the Department of Health and Human Services funds proposals which increase awareness of chronic disease for public health practitioners, patients, healthcare providers, and the public. Projects must choose a chronic disease to focus the research on. Methods can include date dissemination, developing survey tools to fill date gaps and educational activities for increasing awareness based on evidence-based clinical and population-level approaches. **The grant will fund between \$300,000 and \$400,000 with no required cost share for up to 12 months. Full proposals are due May 10, 2024.**

ARTS

Individual Artist Career Opportunity Grants: 1 JUL 2024 & 30 JUN 2025

[The Individual Artist Career Opportunity Grants](#) from South Arts funds grants that will allow individual artists to make a significant opportunity for a career milestone. Artists with disabilities, BIPOC, LGBTQ+ are all encouraged to apply as well. Examples of significant career milestones include solo or group exhibitions, selling, presenting, or performing original work for a major festival, showcase, screenings and panels associated with media arts, artists residences, and travel. This program does not fund groups of artists. **This grant will pay up to 2/3 of the total cost of the opportunity between \$500 and \$2,000. A 2:1 match is required. Proposals are due December 31, 2024, and June 30, 2025.**
